Chandrapur Maharashtra- 442402 with admission intake capacity of 50 seats for Undergraduate (BHMS) course for academic year 2023- 24- reg.**

Purushottamdas Bagla Homoeopathic Medical College and Hospital, Pathanpura Gate, Marda Road, Arwat, Dist. Chandrapur Maharashtra- 442402 has submitted an application for permission for sanction of 50 seats in BHMS course for the academic year 23-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under NCH Act 2020. As per 29(3) of NCH, Act 2020.

MARBH has examined the submissions made by the College. As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard requirements.

The college shall fulfill the following shortfalls:-

- A. Teaching faculty:** - Total 20 fulltime faculty for UG are submitted in part -1 against the requirement of 24 as per MSR2013. On examining few deficiencies are observed:-
- There are no lower faculty available in Department of Organon of Medicine.
  - There is no higher faculty (Professor/Reader) in Departments of Anatomy, Pathology and Repertory.
- B. Hospital details:-**
- Case records are not submitted against the direction issued from MARB. IPD and OPD case records (copy of one OP and one IP cases of 1<sup>st</sup> and last day of every month) shall be submitted for verification
  - Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.
  - Case sheets shall be maintained with complete case analysis and evaluation and repertorisation and made available in medical record room for academic purpose of students.
  - Lab investigation report should be maintained properly in case records.

- All follow up attendance should be recorded on the case records.
- Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

All the shortfalls observed in your College shall be rectified within a period of 30 days and compliance report shall be submitted to the MARB. Considering the above observations, and facilities available, MARB has decided to issue **Conditional permission to Purushottamdas Bagla Homoeopathic Medical College and Hospital, Pathanpura Gate, Marda Road, Arwat, Dist. Chandrapur Maharashtra- 442402 for (BHMS) course for the academic year 2023- 24 with intake capacity of 50 seats.**

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
