Sub: Application for letter of permission for functioning of Purushottamdas Bagla Homoeopathic Medical College & Hospital, Pathanpura Marda Road, Arwat, Dist. Chandrapur- 442402 for continuing BHMS course with intake capacity of 50 seats for the academic year 2025-26 - regd.

Sir,

Purushottamdas Bagla Homoeopathic Medical College & Hospital, Pathanpura Marda Road, Arwat, Dist. Chandrapur- 442402 is functional since 1974 and has applied for permission for sanction of BHMS course with intake capacity of 50 seats for the academic year 2025-26. The college has submitted Part I information in which the entire functional profile has been narrated. MARBH conducted inspection on 12.06.2025 & 13.06.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 & 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls:

1. Deficiency of Teaching Faculty: (07 deficiencies)

- i. In Department of Anatomy 01 Associate Professor is deficient.
- ii. In Department of Physiology 01 Associate Professor is deficient.
- iii. In Department of Organon of Medicine 01 Associate Professor is deficient.
- iv. In Department of Homoeopathic Materia Medica 01 Associate Professor is deficient.
- v. In Department of FMT 01 Professor is deficient.
- vi. In Department of Gynecology & Obstetrics 01 Professor is deficient.
- vii. In Department of Community Medicine 01 Professor is deficient.

As evident from the above statement, a total number of 07 teachers are deficient against the requirement of 40+1 for 50 seats UG college (As specified in MES,2024). Pursuant to F.No. :3-2/MARBH/NCH/2025-26/162-169 dtd. 16/04/2025 issued by MARBH, a college can avail 15% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 15%, college still have deficiency of 01 teachers. However, such relaxed teachers should also be appointed at the earliest for smooth conduct of course.

2. Miscellaneous:

- i. In hospital staff 01 Surgeon, 01 Gynecologist and 02 house physicians are not available.
- ii. In hospital staff 01 Pathologist, 01 Pharmacist and 01 X- ray technician are not available.

- iii. Pay scale of all the teaching staff is not according to MES- 2024.
- iv. NABL accreditation for laboratory is not available.
- v. 18 % GST (36,000/-) of processing fees in NOT PAID.
- 3. Considering the above observation during inspection, MARBH has decided to issue Conditional Permission to Purushottamdas Bagla Homoeopathic Medical College & Hospital, Pathanpura Marda Road, Arwat, Dist. Chandrapur- 442402 for continuing BHMS course with intake capacity of 50 seats for the academic year 2025-26 on the basis of following conditions:
 - i. College should apply for NABL within one month of issue of letter.
 - ii. Pay scale of all the teaching staff should be according to MES- 2024 within one month of issue of letter.
 - iii. College should appoint 01 Professor in Department of Gynecology & Obstetrics within one month of issue of letter.
 - College should pay 36,000/- 18% GST amount of processing fees within 3 days of issue of letter.
 - v. College should appoint hospital staff of 01 Surgeon, 01 Gynecologist and 02 house physicians within one month of issue of letter.
 - vi. College should appoint hospital staff of 01 Pathologist, 01 Pharmacist and 01 X- ray technician within one month of issue of letter.
- 4. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate (BHMS) seats of the permitted intake capacity of 50 seats shall be treated as Ail India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT Govt. as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.
- 5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
- 6. Conditions under point 3 should be fulfilled within a period of one month and the compliance report shall be submitted for verification to the office, failing which permission for the academic year 2025-26 may be withdrawn.
